

## BYLAW NO. 2025-2

### CEMETERY BYLAW

#### A Bylaw of the Rural Municipality of Browning No. 34, in the Province of Saskatchewan, being a Bylaw to amend Bylaw No. 13

The Council of the Rural Municipality of Browning No. 34, in the Province of Saskatchewan, enacts as follows:

1. Bylaw No. 13, being a Bylaw of the Rural Municipality of Browning No. 34 to provide for the Regulation and Control of all Cemeteries within the Municipality, is amended in the manner set forth in this section.
  - a) Section 3. is amended by striking out “**the sum of Four dollars for each grave**” and substituting “**the sum of Two Hundred dollars for each grave**”.
  - b) Section 4. is repealed and the following substituted:  
**4. The Administrator shall keep a listing of all existing burials and reservations within each Cemetery.**
  - c) Section 6 is amended by striking out “**Treasurer**” and substituting “**Administrator**”.
  - d) Section 7 is amended by striking out “**expend a sum not to exceed \$100.00 in the erection of**” and substituting “**erect**”.
  - e) The following Section is added after Section 15.:  
**15.1. No one shall bury any person or remains of a person in a Cemetery before notifying the Municipality 48 hours before any burial.**
2. Schedule “A” to this Bylaw shall be the reference copy of Bylaw No. 13 as amended by this Bylaw.
3. This Bylaw shall come into force and take effect upon final passing thereof.

A Bylaw of the Rural Municipality of Browning No. 34 to provide for the Regulation and Control of all Cemeteries within the Municipality

---

The Council of the Rural Municipality of Browning No. 34 enacts as follows: -

1. That the management and control of each Cemetery in the Municipality be and hereby is vested in the Municipal Council and they shall have the control and management of each Cemetery.
2. That all lands purchased and set apart for any Cemetery be subdivided into Blocks and Lots and that plan of same be registered in the proper Land Titles Office, and that two copies of each plan be obtained for the use of the Council.
3. That burial lots in the said Cemetery may be sold to applicants the whole of the purchase money to be paid down at the time of selecting the lots at and for the following prices and sums, that is to say **the sum of Two Hundred dollars for each grave.**
4. **The Administrator shall keep a listing of all existing burials and reservations within each Cemetery.**
5. The Council shall from time to time designate and set apart some portion of each Cemetery for the interment of the poor and all persons unable to pay the necessary cost of a lot may obtain graves in said portion free of cost.
6. All moneys received from the sale of burial lots in any Cemetery shall be paid to the **Administrator** and kept in a separate account and shall be applied solely to the purchasing, laying out, ornamentation and care of the said Cemetery and roads and accesses to the same.
7. That on receipt by the Council of a petition from the ratepayers in the vicinity and the passing of a resolution accepting same and voting the appropriation the said Council shall be and hereby is authorized to **erect** a suitable build for shelter at any Cemetery.
8. Proprietors of lots shall not allow interments to be made therein for a remuneration.
9. The proprietor of any lot shall have the right subject to the approval of the Council, to erect any proper stones or monuments thereon and to cultivate shrubs and plants in the same, but no tree or shrub growing within the lot or border shall be cut down or destroyed without the consent of Council.
10. If any monument, enclosure or any inscription be placed in or upon any lot which shall be deemed by the Council to be improper or injurious to the appearance of the lots or graves, they shall have the right to remove the said object or objects.
11. The proprietors of lots and their families shall be allowed access to the grounds at all times.
12. Purchasers may improve their lots whenever it suits their convenience.
13. The Council shall have power to employ such surveyors, gardeners and caretakers as they deem necessary and pay them such remuneration as may be deemed proper.
14. The caretaker shall have supervision over the whole Cemetery subject to the direction of the Council.



15. Any person who wilfully destroys, mutilates, defaces, injures or removes any tomb, monument, gravestone or any structure placed in the Cemetery or any railing or other work for the protection or ornamentation of the Cemetery or burial lot, or wilfully destroys, cuts, breaks or injures any tree, shrub or plant in the Cemetery or plays any game or sport or discharges firearms (save at a military funeral) or who wilfully or unlawfully disturbs persons assembled for the purpose of burying a body in the Cemetery or who commits a nuisance, or at any time behaves in an indecent and unseemly manner in a Cemetery shall be subject to the penalties provided by the By-law for the enforcement of the By-laws of the said Municipality.
- 15.1 No one shall bury any human remains in a Cemetery before notifying the Municipality 48 hours before any proposed burial.**
16. No grave shall be opened nor disinterment allowed without permission of the Council.
17. It shall be unlawful to bury any person within the limits of any hamlet of the Municipality.
18. All persons are prohibited from picking any flowers, either wild or cultivated, or from wrecking any tree, shrub or plant.
19. All persons are prohibited from writing or defacing or injuring any monument, fence or other structure in or belonging to the Cemetery.
20. All persons disturbing the quiet and good order of the place by noise or other improper conduct, or who shall violate any of the Cemetery rules will be removed from the grounds.
